Meeting called to order at 7.09 pm

### 1. Election of Officers

## 5. Staff Report

Gregg provided the following information:

- Circulated copies of the updated Draft Community Events Signs Information, Sign requirements on City property and Community Event Sign application. Once finalized these will be distributed to RSC members via e.mail
- Terry made reference to the signs along Steveston Highway and the possibility of the City leasing these signs for use by sports and community groups. The use of School Board signs was also suggested. Gregg committed to following up

  there was a need to work with the City re business license, bylaws, fire and VCH,
  advance approval was required

Serj commented on the booking of Latrace Infield which needed to be addressed as this was highly sort after by many groups and outside users and challenges had arisen with bookings e.g. March 4 from 11 30 am to 4 pm Latrace was empty and 12 noon to 3 pm just this past weekend. The resource was being under utilized. Gregg responded that he would follow up with regard to the why the field was empty and provided the rationale for why one of the times identified caused the field to be empty.

# 7. **Concussion Report**

Stu confirmed that updates from ViaSport were always posted on the RSC Facebook page and encouraged everyone to check regularly.

## 8. **Discover Your Sport Update**

Stu reported that due to scheduling conflicts there would be no indoor event this year and the focus would be on the outdoor event at the City Works Yard Open House on Saturday May 12 from 11 am thru 3 pm. More information to follow including a registration process.

## 9. Wall of Fame Update

Councillor McNulty stated that the Committee had decided upon a rotating chair every 2 years and he was now the current chair. Bill gave thanks and appreciation to the previous Chair, Bob Jackson for his contribution to the committee.

To date there were 12 individuals and a number of teams that are pending approval by Council.

Bob, Donna and Stu had looked into the status of the current Wall of Fame placement and had recommended that there was a need to remove the wall and increase visualization of the members of the wall throughout the City. Councillor McNulty had discussed this recommendation with the CAO who had committed to look at other areas for the wall and would respond with information in this regard.

## 10. **Sport Hosting Update**

Robin confirmed that 13 applications had been received to date and committed to send out information on priority bookings for RSC members via e.mail. A number of events are pending at the Oval and Robin provided details.

## 11. Creating Community Champions Gala Event

Bob expressed his appreciation to Sanjeet and the Hilton Hotel and their continuing support for this event for another 5 years and members gave a round of applause in gratitude. Bob confirmed that a net profit of approximately \$48,000 had been raised. A meeting will be held with the Hilton Hotel to confirm the date for 2019.

# 12. Sports Awards Report

Terry reminded everyone of the date for this event <u>Thursday April 26<sup>th</sup></u> Tickets will be on sale e April 1<sup>st</sup>. Terry committed to sending out the list of nominees via email.

## 13. KidSport

Bob confirmed 76 applications to date this year with funds of \$12,933 provided. A City grant had been approved in the amount of \$21,000 with approximately \$30,000 in grant funding pending. Bob drew attention to the outstanding cheques and concluded by providing a list of the sports groups that had been allocated funds.

# 14. Facility Needs Assessment Update

Jim confirmed that the third meeting of this committee would take place on Thursday March 15<sup>th</sup>. Jim noted that some of the facilities were over 50 years old now and in need of replacement.

## 15. BC Seniors Games Host

Jim enquired if the members would like to submit a bid for 2020, 2021 or 2022. Following discussion and a number of questions, the members requested that the full bid package be circulated and Gregg committed to following up and providing an electronic copy. Jim asked that a decision be made at the April meeting.

It was also decided to form a small committee to review the bid with Jim, Bill, Sport Hosting and Steve volunteering their services. There would also need to be a letter sent to Council and the School Board to solicit their support.
